- Contributors are fully responsible for the content submitted to *Charlie – Your Student Voice*, including images, sound, video and text (Content). Charles Sturt University is not liable in any way for Content to the full extent permitted by law.
- Charlie Contributors own the copyright to the content published on *Charlie – Your Student Voice*. For additional information regarding copyright visit [Copyright for Students](#).
- Content posted on *Charlie – Your Student Voice* and Charlie Contributor names may be used by Charles Sturt for promotional purposes.
- The views of Charles Sturt students expressed in Charlie are those of the respective authors, and not necessarily those of the University.

2) As a Charlie Contributor, you warrant and agree that:

- a) you will not submit any Content that is unlawful or fraudulent, or that Charles Sturt may deem in breach of any intellectual property, privacy, publicity or other rights, defamatory, obscene, derogatory, pornographic, sexually inappropriate, violent, abusive, harassing, threatening, objectionable with respect to race, religion, origin or gender, not suitable for children aged under the age of 15, or otherwise unsuitable for publication;

- c) you will only submit Content which you have personally created;
- d) your Content will not contain viruses or cause injury or harm to any person or entity; and

3) Charles Sturt reserves the right to remove your Content, in its absolute discretion, if:
